



# John and Muriel Arnason Award

## Nomination Criteria

Created in 2009, the John and Muriel Arnason Award is awarded to a couple for outstanding volunteerism in the Township of Langley. Created to honour the memory of Muriel and John Arnason, the award recognizes people who volunteer together to make Langley a better place.

The award recognizes a partnership of individuals who:

- are advocates of culture, learning, and literacy
- are sensitive to the economic needs, abilities, and specific needs of Langley residents
- foster partnerships and cooperative efforts
- create the potential for long-term benefit to the Langley community

### Eligibility

Individuals must:

- be related or connected in some way\*
- reside in the Township of Langley
- serve together to make the Township of Langley a better place through charitable, philanthropic, or other means

\*The recipients must either have a family connection (married, common-law, parent and child) or be a team of two people who are non-related but are colleagues or friends who have partnered together for a common goal.

### Submission Requirements

- Complete the Nomination Form
- Attach documents detailing the nominees' background, experience, and achievements
- Include a minimum of two supporting letters from benefiting persons, newspaper clippings, and any other pertinent information
- Attach or email a recent high quality photo of the nominees (together):
  - » head shot
  - » jpg format (300dpi or 2-4mb)
- Attach or email any high quality photos of the nominees completing volunteer work:
  - » jpg format (300dpi or 2-4mb)
- Photos provided may be used in newspapers, websites, and Township of Langley publications

### Additional Notes

- The quality of your submission greatly assists the selection committee
- Please print clearly
- The selection committee will contact:
  - » the nominees to verify the application content
  - » the nominator for further input as required
- Although only one submission is selected as the award recipient, the Township believes all nominees make an important contribution to the community and, therefore, all nominees will be awarded a recognition plaque at the awards event

## **Additional Notes (continued)**

- A monetary award will be presented to a recognized charity or society chosen by the award winner
- Applications cannot be accepted in consecutive years. Once a candidate has been nominated, there needs to be a significant change in the body of work or a substantial period of time in order to be nominated again
- Nominees and award recipients are requested to attend the Township of Langley's annual Volunteer Appreciation and Awards Evening on **Thursday, April 4, 2019**, to receive their plaque or award

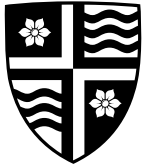
