## Notice of Road Closure, Highway Dedication Removal and Disposal

Notice is hereby given of the intention of the Council of The Corporation of the Township of Langley, pursuant to Sections 40 and 94 of the *Community Charter* S.B.C. 2003, c. 26, to adopt "Highway Closing and Dedication Removal (Zenterra) Bylaw 2020 No. 5638".

The intent of the Bylaw is to close and remove the dedication of road from a 758.8 square metre portion of 75A Avenue at 199A Street. The closed road will be sold to Zenterra West End 2.0 Developments Ltd., for the sale price of \$570,150, to be developed with their adjacent lands.

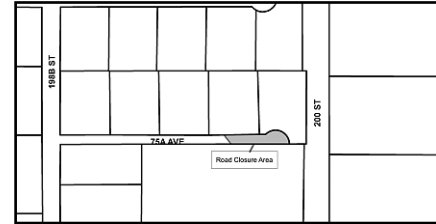
The road being closed is noted on the plan.

## Notice of Road Closure, Highway Dedication Removal and Disposal

Notice is hereby given of the intention of the Council of The Corporation of the Township of Langley, pursuant to Sections 40 and 94 of the *Community Charter* S.B.C. 2003, c. 26, to adopt "Highway Closing and Dedication Removal (Janda) Bylaw 2020 No. 5637".

The intent of the Bylaw is to close and remove the dedication of road from a 664.4 square metre portion of lane adjacent to 27309 Fraser Hwy. In exchange, the applicant, Janda Group Holdings Inc., will dedicate 681.1 square metres of 27309 and 27329 Fraser Hwy. as new road.

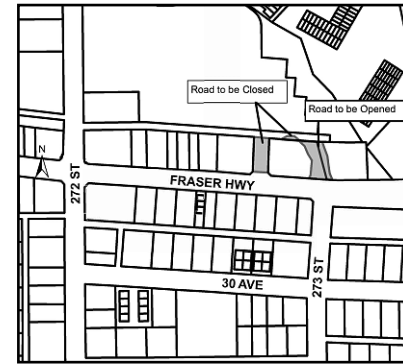
The portions of road being closed and dedicated are noted on the plan.
