



Eric Flowerdew Volunteer Award

Nomination Criteria

The Eric Flowerdew Volunteer Award is given in recognition of a volunteer's contribution to the promotion of an active living lifestyle which enhances our residents' quality of life through creative, cultural, physical, or social pursuits and enhances Langley's community spirit.

The award recognizes an individual who:

- is sensitive to the variety of ages, abilities, and special needs of Langley residents
- fosters partnerships and cooperative efforts
- promotes traditional and non-traditional recreation activities
- possesses leadership and team building qualities
- has contributed a significant and diversified body of work

Eligibility

Individual must:

- reside in the Township of Langley
- act in an unpaid volunteer capacity within the Langleys for the contributions being cited

Submission Requirements

- Complete the Nomination Form
- Attach supplemental documents detailing nominee's background, experience, and achievements
- Include a minimum of two supporting letters from benefiting persons, newspaper clippings, and any other pertinent information
- Attach or email a recent high quality photo of the nominee:
 - » head shot
 - » jpg format (300dpi or 2-4mb)
- Attach or email any high quality photos of the nominee completing volunteer work:
 - » jpg format (300dpi or 2-4mb)
- Photos provided may be used in newspapers, websites, and Township of Langley publications

Additional Notes

- The quality of your submission greatly assists the selection committee
- Please print clearly
- The selection committee will contact:
 - » the nominee to verify the application content
 - » the nominator for further input as required
- Although one person is selected as the award recipient, the Township believes all nominees make an important contribution to the community and, therefore, all nominees will be awarded a recognition plaque
- Nominations of couples will not be accepted
(refer to the *John and Muriel Arnason Award* for recognition of couples)

Additional Notes (continued)

- A monetary award will be presented to a recognized charity or society as chosen by the award winner
- Applications cannot be accepted in consecutive years. Once a candidate has been nominated, there needs to be a significant change in the body of work or a substantial period of time in order to be nominated again
- Awards will be presented privately, at an intimate, physically distanced ceremony at the Township of Langley's Civic Facility in Spring 2021
